**OFFICE ORDER NO. 124/2012**


The President is pleased to appoint the officers mentioned in **Annexure-I, II and III** to the grade of Assistant Commissioner of Customs & Central Excise in Pay Band 3 with Grade Pay of Rs 5400/- (Rs 8,000-13500 pre-revised) on promotion on purely *ad-hoc* basis, **with immediate effect**. The appointment is for a period of six months or until further orders, whichever is earlier.

2. The promotion, being purely on ad-hoc basis for a limited period of six months only, does not confer any right on the officers so promoted for any claim for continued officiation or regular promotion in the grade and the period of such service shall not count for seniority or as qualifying service for further promotions.

3. The ad-hoc promotions of the officers mentioned in **Annexure-I, II and III** shall be on *in-situ* basis, until further formal posting/ transfer orders that will be issued separately.

4. The ad-hoc promotions on in-situ basis shall be subject to the outcome of implementation of the Hon'ble Supreme Court's order dated 03.08.2011 in CA No. 1198 of 2005 and other orders/judgements applicable, if any, in pending court cases relating to seniority of IRS (C&CE) Group 'A' officers or any other related issue.

5. The Chief Commissioners / Commissioners/ Directors General / Additional Directors General concerned shall ensure that if any of the officers, whose name figures in the promotion lists at **Annexure-I, II and III** to this order, is **under suspension or facing any charge sheet or prosecution**, he / she shall **not be allowed** to assume charge in the grade of Assistant Commissioner and this fact be reported to the Board immediately.




