
2 The promoted officers should join **on or before 12th Sep 2013** failing which their promotion to the higher post will be treated as cancelled. The officers will be on probation for a period of two years from the date of assumption of charge as Superintendent of Central Excise & Customs and will not be considered for further promotion / retention unless they complete the probation period satisfactorily.

3 The above officers will have to exercise the option for pay fixation in terms of Department of Personnel & Training's O.M. Dated 26.09.81 and 05.07.99 within one month from the date of joining the new post.

4 The above promotions are subject to the outcome of SLP No. 20810/2012 filed by the Department against High Court Order dated 28.03.2012 in OP (CAT) No. 4305/2011, OP (CAT) No. 999/2012, OP (CAT) No. 998/2012, OP (CAT) No. 968/2012 and other related orders of Courts/Tribunal on this issue.
