Central Excise & Customs and Transfers - reg.

Consequent to sanction of additional posts under Board's letter No. A-11019/08/2013-Ad.IV dated 01.08.2014 and holding supplementary DPC for the year 2014-15, and in pursuance of DGHRD letter F.No. 8/B/130/HRD(HRM)/2014 dated 25.08.2014, the following Inspectors of Central Excise & Customs are promoted on regular basis to the grade of Superintendent of Central Excise & Customs, Group 'B' post in the Pay Band of PB2 : Rs.9,300- 34,800/- with corresponding Grade Pay of Rs.4,800/-, with effect from the forenoon of 30.09.2014 on an in-situ basis, until further orders. All the promoted officers will continue in their present places of posting till regular posting orders are issued and they are required to continue to work and discharge the same duties and responsibilities as at present until further orders.

2.) The promotion order issued is subject to the condition that the officers concerned join latest by 10.10.2014 failing which it will be treated that they have not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow.

3.) The officers on promotion will be on probation for a period of two years from the date of assumption of charge as Superintendent of Central Excise & Customs and will not be considered for further promotion / retention unless they complete the probation period satisfactorily.


4.) The officers promoted should exercise option for fixation of pay in terms of FR 22 I (a) (i) within one month from the date of joining as Superintendent. However, the officers who have already been granted financial upgradation under Assured Career Progression Scheme/ Modified Assured Career Progression Scheme are not entitled for any fixation benefits now.

5.) The promotion of the Inspectors to the grade of Superintendent mentioned in the above table and their seniority in the grade of Superintendents are subject to the outcome of SLP No. 20810/2012 filed by the Department against High Court Order dated 28.03.2012 in OP (CAT) No. 4305/2011, OP (CAT) No. 999/2012, OP (CAT) No. 998/2012, OP (CAT) No. 968/2012, O.A.No. 180/00806/2014 in CAT(EB) and other related orders of Courts/Tribunal on this issue.

6.) The Controlling Officers/Officers concerned should issue/generate joining report compulsorily, by [www.cepsonline.in/mypay](http://www.cepsonline.in/mypay) website using their login id and password. The compliance report about joining/non-joining of the officers should be sent to this Office by 13.10.2014.
